Impact: Undermines father's role

EVIDENCE ANALYSIS

PATTERN IDENTIFICATION

1. WITHHOLDING CHILD AS WEAPON

- **Frequency:** Continuous after July 17
- **Method:** Direct admission in writing
- **Reason:** Personal feelings, not child safety
- **Impact:** Clear custodial interference

2. FINANCIAL EXTORTION

- **Total Demands:** \$339
- **Method:** Using child access as leverage
- **Urgency:** "today" demands
- **Pattern:** Multiple demands over time

3. VERBAL ABUSE

- **Frequency:** 30+ documented instances
- **Type:** Personal attacks, character assassination
- **Impact:** Creates hostile co-parenting environment

4. PARENTAL ALIENATION

- **Statements:** "he will not be raised and be like you. Ever"
- **Actions:** Public disparagement, limiting family access
- **Goal:** Damage father-child relationship
